Czech exports to Iceland

- Measured by trade turnover, Iceland has a marginal position in terms
 of Czech foreign trade. According to CZSO statistics, Iceland placed
 seventieth in terms of trade volume. For Iceland, however, in 2018 the
 Czech Republic was Iceland's twenty-fourth largest importer more significant than Australia, Canada or South Korea.
- The level of Czech exports increased by 3% in 2020 to EUR 35.2 million. Imports from Iceland into the Czech Republic also increased by 8% to EUR 69.1 million.
- Metrostav has long been a major player in Iceland. In 2010, it completed the construction of the first two double-lane Sigla (3.6 km long) and Ólafs (6.9 km) tunnels. Together with its Icelandic joint-venture partner, Suðurverk hf., Metrostav began work in 2013 on the construction of
- the 7.5-km-long Norðfjörður tunnel complex in the east of the country; in 2017 the complex was completed and went into operation. The Norðfjörður project constituted the largest infrastructure-based investment in Iceland since 2008.
- In October 2020, Metrostav completed the new Dýrafjarðargöng road tunnel, which is 5.3 km long.
- The structure of Czech exports to Iceland has undergone no major changes. Dominant, in terms of SITC classification, is the "machinery and transport equipment" category, which accounts for 63.4% of exports, followed by "miscellaneous manufactured articles" with a share of 17%.
