Czech exports to Norway

- According to the statistics for 2019, Norway is the twenty-seventh most important trading partner in terms of the value of exports of goods and services from the Czech Republic, while in terms of imports it is in forty-second place.
- In 2013 the balance of trade between the Czech Republic and Norway and the Czech Republic was negative owing to the large volumes of Norwegian natural gas purchased: natural gas represented more than three quarters of all imports from Norway. After this item was deducted, however, trade between the Czech Republic and Norway remained positive as regards traditional commodities. In 2014 there was a reduction in the level of imports of gas, after the Czech Republic has began concluding purchase contracts in Germany. As regards trade with Norway, this change in billing method placed the Czech Republic in the position of a significantly more active exporter, and the value of exports from the Czech Republic to Norway shows a long-term upward trend. Between 2016 and 2017, the Czech Republic's positive trade balance with Nor-

- way doubled. With respect to the 2020 pandemic year, overall turnover decreased by 14% to EUR 958 million in 2020.
- The main Czech exporters to Norway include the following companies: ELFE, s. r. o. (which sub-contracts for marine platforms); FAGUS a.s. (prefabricated buildings); Hutní montáže, a.s. (crane technology); Chart Ferox, a.s. (liquefied gas transport and storage facilities); JUTA a.s. (foils for building, agrotextiles, and waterproofing foils); KOMA Modular s.r.o. (prefabricated buildings); Metrostav a.s. (construction of transport infrastructure); Sandvik Chomutov Precision Tubes, spol. s r.o. (specialised-use stainless steel and titanium); ŠKODA AUTO a.s. (cars), and Třídič, s. r. o. (mobile sorting and crushing machines).
- The structure of Czech exports to Sweden has undergone no major changes. Dominant, in terms of SITC classification, is the "machinery and transport equipment" category, which accounts for 64.7% of exports, followed by "manufactured goods" with a share of 17.4%.
