Czech export to Denmark

- According to available statistics for 2017, there is a significant increase
 in mutual trade. Especially in exports of the Czech Republic, the extraordinary expansion occurred in the last five years, with a growth of
 about 55%. Although the value of imports has not increased so sharply,
 there is an increase in trade relations of more than 20%. The overall
 trade balance is positive.
- 13 300 Škoda cars were sold in 2015, which is a 7 % share of the Danish Market. Czech exports of Toyota, Peugeot and Citroën cars from TPCA works in Kolín are growing as well.
- The overall structure of Czech exports to Denmark remains without ma-
- jor changes. Dominant, according to the classification of SITC classes, the item "Machinery and transport equipment" is 45.6%, followed by the item "Chemical products s" with a share of 29.6%.
- In general, energy industry, railway transport, construction and agricultural and food industry is an essential part of Czech export to Denmark.
- Important goods in Czech exports include products of the beer brewing industry
- Significant Czech exports are ferrous and steel products, electrotechnical and communication products, automatic data processing equipment, recording media, memory units, TV receivers, etc.
